Pupil Premium Grant – Spending Plan Sept 2019 – July 2020

Winterbourne Nursery and Infant school is committed to the development of the whole child and we provide care for pupils which acknowledges that young people and families at times need more than simply an academic curriculum. We provide family support through our Family Support Worker. Our Pupil Premium strategy is bespoke, it's targeted and it's obvious. We try to engage rapidly with issues, build trust quickly and start early intervention to break down complex barriers, once and for all. High expectations and consistency of progress and achievement for all pupils is embedded throughout our school and this is enhanced further by ensuring that Pupil Premium funding is used to maximum effect.

No one child is the same and thus this is reflected in the wide variety of ways Pupil Premium funding is utilised. The provision provided by WNIS encompasses both direct approaches to 'narrowing the gap' and other more creative interventions, which subsequently influence academic achievement and very importantly enhance the social and emotional well-being of students who are eligible for Pupil Premium. We believe that Pupil Premium should be used to impact the wider school but it is also pertinent that the Pupil Premium is specifically tailored to meet the needs of individual pupils who are eligible for the funding, in addition to, and in different ways from, our other intervention programmes.

Our key ethos and aims include:

Winterbourne Nursery and Infant School adopts a whole school approach with all staff being empowered and accountable for our Pupil Premium pupils. It is a key focus for Leadership with a shared purpose and vision. There is one person designated as strategic lead for Pupil Premium, this is the Inclusion Manager/SENDCo, but the whole team acknowledge the vital importance of a successful Pupil Premium approach.

There should be no gap in progress or attainment between Pupil Premium pupils and non-Pupil Premium pupils. Pupil Premium funds will be ring fenced to directly benefit and target Pupil Premium pupils; they will be specifically tailored to meet their individual needs and the provision will include strategies which are in addition to and different from other intervention programmes, as required.

All expenditure is evaluated using key performance indicators, including attendance, attainment, progress and punctuality.

Pupil Premium is a key focus of teaching and learning and plays a crucial part in planning, monitoring and assessment by all classroom teachers.

The pupil premium was introduced in April 2011 and is allocated to children from low income families who are known to be eligible for Free School Meals (FSM) in any of the last 6 years, or have been looked after continuously for more than 6 months.

The Government believes that the Pupil Premium is the best way to address the current underlying inequalities between children eligible for FSM and other children by ensuring the funding reaches the children who need it most.

It is up to the School to decide the best way to spend the pupil premium and as a school we have had an immense success rate at narrowing the gap.

For the academic year 2019-2020 Winterbourne Nursery and Infant School expects to receive a pupil premium of £64,680.

## What has been the impact of the spending?

Whereas we recognise that standards across the school were low last year, for all pupils the pupil premium spending has had a demonstrable effect on raising standards of behaviour and well-being for disadvantage pupils; and for narrowing the gap between performance of disadvantaged pupils and those who were not eligible for pupil premium spending.

PP funding has helped pupils make significant progress last year. We will ensure that this is maintained and improved on in 2019 -2020. Pupil premium spending allocated to areas to increase cultural capital of pupils (eg Author visits and music activities) has had a strong impact on increasing the access to these activities. For many of the disadvantaged children these have been the first experiences of this type. They have demonstrated that they can remember and talk about their experiences Pupil premium funding has allowed us to ensure that all children have had an enriched educational experience by having access to good quality educational visits. This is essential for the social and cultural development of our pupils. These experiences have also fed back into the more traditional curriculum as they have memorable and relevant experiences to enhance understanding and to stimulate writing.

A large area of focus for us this year was to improve pupils' attitudes to learning. Additional targeted and focussed pupil premium resources have shown that our disadvantaged children have shown an increasingly positive attitude to learning on a day to day/ lesson to lesson basis.

Our outside space has been improved and used to extend learning beyond classroom. Pupils have benefitted from this as learning has been made more relevant.

The number and quality of books have been increased and the children now have access to a wider range of fiction and non-fiction texts. All children have borrowed these books and an increasing number have extended their reading time.
